

# Component III Inspection

The last step of the licensing process is an inspection of your facility. After your successful completion on the Component II interview, your Analyst will ask your regional licensing office to contact you to schedule a Component III inspection, also known as a pre-licensing inspection.

Your Analyst will also email you a Pre-Licensing Self-Certification checklist. The checklist is used to help you ensure the furnishings, supplies, and postings required are in place before your pre-licensing inspection occurs.

### **ARF**

Facility visiting policy - Print the Visitation Policy from your Part B application, Section B7, on a separate page.

#### **RCFE**

Facility Theft and Loss Program – Print Section B14 from your Part B application on a separate page.

# **Employer Forms and Links**

The following are not required for your pre-licensing inspection but will be useful once you begin operating your business and hiring staff.

Some companies will package forms that are free and want to charge you for them. Per the <u>Department of Industrial Relations</u> website "In California, all employers must meet workplace posting obligations. Workplace postings are usually available at no cost from the requiring agency." DO NOT PAY for items that are free, but that may be hard to find. Here are links to some forms your facility will need:

Some companies also offer all the free labor law postings condensed into a single, large, laminated poster, but the prices vary wildly. We have found them for as little as \$13.99 simply by Googling 2025 Federal and California Employment Posters. If you use a payroll service, such as Paychex or ADP, these posters will typically be mailed to you as part of their service every year.
